

## Nanke Invitational Forensics Tournament



### Greetings Speech and Debate coaches, Judges and Participants!

It is my utmost pleasure, on behalf of the International Bilingual School at Tainan Science Park (IBST), to invite you to **2025 Nanke Invitational Forensics Tournament (NIFTy)**.

We here at IBST are excited to make this year's NIFTy tournament bigger and better than ever! As always, that starts and ends with the commitment and participation from all of you! It is because of all of your hard work and dedication that NIFTy continues to be one of the premier speeches and debate tournaments on the island.

We hope you will join us on **Saturday March 22nd and Sunday March 23rd** for a weekend of great debate, speech, food, and fun!

This year's tournament will include multiple individual and partner speech events, as well as **Modified World School Parliamentary Debate**. Schools may submit teams of students competing from middle school and above.

Speech participants must pay a tournament fee of **\$800 NT** while Debate participants must pay a tournament fee of **\$1000 NT** which will cover the cost of Lunch on both Saturday and Sunday, as well as all trophies, medals, and judges' appreciation. While teams can be submitted through online application form as soon as possible, fee payment can be made in cash after arriving at IBST on **Saturday, March 22nd**.

In addition, schools must provide one judge for two debate teams or one judge for every team of 5 speech competitors (See Section C for Judge requirements). Otherwise, schools must provide an additional fee of 1000NT per missing judge.

**Speech** competitors will NOT be able to compete in Debate due to schedule conflicts. ALL SPEECHES AND PERFORMANCES MUST BE ORIGINAL WORKS. Speech events include **Duo Interpretation, Impromptu Speaking, and Editorial Commentary**. Grade 7-9 will be considered as Junior Varsity (JV) and Grade 10-12 will be considered as Varsity. **Debate:** If the participant is competing in Debate, then the participant can NOT compete in speech events due to schedule conflicts. Debate will be divided into Novice and Open debaters. (see [Attachment 2](#))

### B. Team Entry

## C. Judge Requirements

### Speech:

Each school must supply an adult qualified to judge for the tournament. Schools bringing more than 5 contestants must supply 2 judges. Any school bringing more than 10 participants, must supply 3 judges, etc. A school not bringing the necessary judges may find some or all of their participants disqualified (due to a judging shortfall). Judges need not have judged events previously.

### Debate:

Judges must be an adult.

- 1 team - one judge
  - 2 teams+ - one judge per 2 teams
  - 3 teams- 2 judges
  - 4 teams- 2 judges
  - 5 teams- 3 judges
  - etc.
- Every odd number requires an additional judge.

**[odd number teams round up (ex. 3 teams 2 judges, 5 teams 3 judges...)]**

If schools don't have enough judges, judge fee 1000 NT per judge (same number of judges apply as mentioned above i.e. 3 teams 2000NT, 5 teams 3000 NT)

## D. Registration Fee and Payment

Each student must pay a fee of \$800NT(speech)/ \$1000NT(debate) in order to complete. This fee will cover the cost of lunch on both Saturday and Sunday, as well as all tournament expenses.

Team fees may be paid upon registration on **Saturday, March 22nd**.

## E. Food and Accommodation

We will provide a list (see [Attachment 3](#)) of nearby accommodations which can accommodate all participants within a quick drive of IBST. For questions regarding booking accommodation, please contact **Alvis Lin** at [activity3@ms.nkieh.tn.edu.tw](mailto:activity3@ms.nkieh.tn.edu.tw) for assistance. If preferred, participants can also find lodging in Tainan, and commute to IBST.

NIFTy will provide, as part of the registration fee, lunch for all judges and contestants on Saturday and Sunday. Within walking distance of the school, there is a 7-11 as well as several tea shops at the nearby Life Hub.

### F. Getting to Nanke

Schools can arrive at Nanke in several ways. If they choose to take a bus, the Science Park and school offer ample parking. Schools can also take the HSR rail to Tainan (Shalun Station) and transfer to the local train headed toward Nanke (the train terminates at Nanke). Schools can also take the fast train or a bus to Tainan. A local train north goes to Nanke. From the Nanke train station, you can take a taxi, or simply walk the 15 minutes to IBST.

### G. Awards

ALL participants will receive participation certificates. In addition, the tournament will award trophies and medals to forensics winners and top debaters.

### 2025 NIFTy Speech Event Descriptions

- (1) Duo Interpretation
- (2) Impromptu Speaking
- (3) Editorial Commentary

Speech competitors will NOT be able to compete in Debate due to schedule conflict. **ALL SPEECHES AND PERFORMANCES MUST BE ORIGINAL WORKS.** Any participants presenting speeches or performances found to be copied from existing or previously performed works will be automatically disqualified from the competition without refund.

#### General:

Ranking is a point-based process. Criteria for earning points are in the ballots provided.

#### (1) Duo Interpretation (Duo):

Two competitors team up to deliver an **8-10-minute performance** of a script written by the performers. Using off-stage focus, competitors convey emotion and environment through the relationships and interactions between characters through a variety of performance techniques. Performances **must** also include an **introduction** written by the students to contextualize the performance and **state** the title and author. Each partner plays a key role in developing the piece's characters, relationships, plot, and more during a duo interpretation. Duo interpretation allows for students to do humorous, dramatic, or pieces that combine both into the performance. Age, maturity, and school standards should all be considered when choosing a topic for a duo interpretation. **No script is allowed on stage for this event.**

#### (2) Impromptu Speaking (Solo):

The impromptu speech is a **short narration** on a topic **unknown** to the contestant until right before his performance. This is a short speech with a hooking introduction, logical development, and a good conclusion. Each participant draws **three** possible topics from the bowl. The speaker has **30 seconds** to choose a subject and **1 minute** to prepare his speech. The speech is **2 minutes**; if he goes over 10 seconds or speaks for less than 2 minutes, he will be **deducted 5 points**.

An example of a prompt might be, "color affects how a person behaves."

#### (3) Editorial Commentary (Solo):

Editorial commentary is a scripted original speech which offers an analysis of and commentary on a current news event. The speaker must read from the manuscript and sit while delivering the speech. The time limit for this event is **between 1:45 and 2:00 minutes**. Students going under or over the time limit by more than 10 seconds will be deducted 3 speaker points. **Script is allowed for this event and should be written before the tournament begins.**

**Modified World Schools Parliamentary Debate**

**I . Rules & Guidelines**

- A. Each team will consist of 3 debaters, with one team on the Proposition side and one team on the Opposition side. The speech times are listed below accordingly in the "Format" section.
- B. Devices should only be used for timing. If it is used for other purposes, it will count as cheating.
- C. Please be respectful to other debaters and your judge. If any participants feel that they have been disrespected or bullied, please bring up your concerns to the tournament organizers.
- D. Debaters will be awarded speaker awards and finalist awards on top of participation awards so please don't be discouraged if your team loses some debate rounds.

**II. Format: Modified World Schools**

- A. Points of Information (POIs) are allowed between the 1st and 6th minute of substantive speeches

### III. Motions (for both Novice and Open debaters)

Motions will be given at the start of prep time before each round.

### IV. Breaking Eligibility

#### Novice Category

1. Debated for less than two year
2. Have not participated in more than 3 international tournaments
  - Need to fulfill both to qualify as a novice speaker
  - If ENTIRE team is composed of novice speakers, the team will qualify as a novice team

Composite teams (debaters from different countries/schools) are allowed
